



# THOMPSON VACUUM-PRESSURE UNITS

## WARRANTY

### FOR NEW THOMPSON VACUUM-PRESSURE AND NEW ACUUM-PRESSURE UNIT PARTS

No warranties expressed or implied, as to Thompson Vacuum-Pressure Units and Thompson Vacuum-Pressure Unit Parts, are made either by Thompson Tank, Inc. or by the distributor except the following warranty issued by Thompson Tank, Inc. (TTI).

TTI warrants, to the original retail customer, that every new Thompson Vacuum-Pressure Unit and new Thompson Vacuum-Pressure Unit Part, will be free from defects in material and workmanship under normal use and service for one year from the date of delivery, provided, the customer has fulfilled all of his obligations pursuant to his purchase agreement, including his obligations as to payment.

The obligation of TTI under this warranty is limited, at the election of TTI, to the repair or replacement of such parts as are acknowledged by TTI to be defective in material or workmanship during the warranty period. Such repair or replacement will be made at such a location as TTI may designate. All parts which are replaced shall become the property of TTI. Under no circumstances will the customer be entitled to rescission or to a reduction in the purchase price or to any direct, indirect or consequential expenses or damages whatsoever.

*TTI's warranty does not cover the following:*

1. *Damage or deterioration due to excessive use, wear, exposure, storage or corrosion.*
2. *Normal maintenance service or parts required to be replaced or repaired in the course of normal maintenance service.*
3. *Damage or defects due to shipping, alteration, negligence, misuse or to the repair of the unit or part in an unauthorized manner.*

This warranty does not cover equipment or parts other than manufactured by TTI. In particular, it does not cover parts or equipment manufactured by suppliers of TTI. Such parts and equipment shall be covered only by such warranties, if any, as may be issued by such suppliers.

This warranty is in lieu of all other expressed or implied warranties of TTI with respect to Thompson Vacuum-Pressure Units, Parts, and other parts and equipment by TTI, including any implied warranty of merchantability or fitness for any particular purpose. TTI neither assumes, nor authorizes any distributor or other person to assume, on its behalf, any other obligation or liability.

Thompson Tank, Inc. would appreciate receiving suggestions and being informed of any problems our customers have concerning the use and performance of our equipment. This will give us the opportunity to offer our assistance concerning warranty work covered by our suppliers as well as our own.
